## THINGS TO KNOW

Here are a couple of other common things to be aware of about the dock program:

- ***Current DNR registration is required every year!***
- Only one watercraft may be moored in each slip at any one time. If you wish to change the watercraft that is moored at your site, please consult with the City.
- No personal items (tubes, etc.) are allowed to float in the water, even if secured to your watercraft. No exceptions are allowed to this, the City will confiscate any such items.
- Undeclared watercrafts at your slip site are subject to a fee of \$100 per occurrence. It is your responsibility to inform the City of any changes in the watercraft at your slip site. If the City is not able to correct an issue such as this, the City has the right to impound your watercraft, with all associated costs being your responsibility.
- Vertical clearance under the Lost Lake Bridge is 11'1" (based on normal lake level of 929.40 feet).
