## A Message from the Mayor

Dear Mound Residents,

The Mound City Council's and my top priority remains securing additional funding for a water treatment plant to address the City's manganese levels in the water. In addition, the City Council is committed to starting support projects that need to be completed before the construction of a water treatment plant.

At the end of 2024, the City Council authorized the City Engineer to complete the design plans for the reconstruction of several watermain that will occur in 2025, the building of a new well that will occur in 2026, and the final design of the water treatment plant that will occur when the City is able to secure the necessary funding.

As for the 2025 watermain project, reconstruction will occur along CSAH 15 from Cypress Lane to Chateau Lane, CSAH 110 from Beachwood Road to Harbor Place, and from the county roads to the City water towers and will take place this summer. I thank you for understanding any disruptions this may cause.

There is still more work to be done and additional funding to secure to get to where we need to be. The first round of funding, in the amount of \$11.26 million, is a significant step towards the final goal of building the water treatment plant. We continue to work diligently towards the completion of this project.

## Enhancing the Utility Bill Process with Invoice Cloud



Invoice Cloud features are projected to be added to the Utility Billing Process now starting in mid-February. The previous projection was January 1. The City of Mound will be incorporating Invoice Cloud to enhance utility customers' payment options and the ability to create and access personalized online account information.

By integrating Invoice Cloud into the City's current process, customers will have the option to make payments through a simple, safe and secure online billing and payment portal. Customers will also be able to: check their current balance, make payments and securely store payment information, receive notifications and pay via text message, set up automatic payments, enroll in paperless billing, set up email reminders and more. New payment options will include credit card, debit card, and other digital payment methods.



### Adopt a Drain

Did you know that you can Adopt a Storm Drain in Mound? City of Mound performs street sweeping regularly during the spring and fall months to clear the streets of debris, leaves and other items, however, things can still fall into the storm water system from the street. ## State of the Water Treatment Plant Project

To date, the City has secured \$10.3 million in state funding for the water treatment plant improvements. The City Council recently authorized the City Engineer to complete the final design of the water treatment plant, the design for the reconstruction of several watermain (mostly under county roads 110 and 15), and the design needed for the construction of a new well. The reconstruction of the watermain will occur this summer. The first phase of the water main reconstruction project is currently out for bid for contractors to bid on. This phase of the project will include upgrading the water main along CSAH 15 from Cypress Lane to Chateau Lane and up Chateau Lane to the water tower. Much of this work will be completed through a trenchless construction process. There will be short-term closures and detours of CSAH 15 to work is being completed on water main lines that cross the street. A reminder to please follow the detours and utilize the access to local businesses as necessary. This work will occur early in the season to prior to the planned Hennepin County mill and overlay street projects later in the year. The second phase of the project is still under the design period. This phase will include the upgrading of the watermain from the water tower on Evergreen Road, snaking out to Beachwood Road and then north on CSAH 110 up to Harbor Place. This will be a significant project throughout the summer. Stay tuned for additional details. In addition to state funding, the City also secured approximately \$1 million in federal funding for additional improvements that support the construction of the water treatment plant. Additional funding requests are in place at the state and federal levels with more news to come.

## Winter Parking Restriction Reminders

There is no overnight parking allowed between 2:00 a.m. and 6:00 a.m. between November 15th and April 15th. In addition, no vehicle can be parked in any one place for a continuous 24-hour period as to allow for thorough and efficient snow plowing. Violators will be towed at the owner's expense.

## Winter Lake Safety

Lake ice is never 100% safe, so take care when on the ice this winter. Ice conditions constantly vary due to factors related to freeze/thaw cycles, snow accumulation, the movement of fish underneath, and wind/sun/temperature conditions. ## Clearing Sidewalks & Property

Please remember to not plow, blow, or shovel snow into the streets. When this occurs, snow on the road can create hazards for drivers, such as drifting and obstructed vision. In addition, if snow is pushed onto the road and it freezes, it can cause accidents.

### Other snow removal tips:

- Shovel adjacent sidewalks as soon as possible after a snowfall.
- Clear snow and ice around fire hydrants.
- Keep your mailbox clear of snow.
- If your collection day is likely going to be a plow day, try and locate your receptacles five feet back into your driveway.
- Keep your gas meter clear of snow and ice.

## Trash and Recycling Carts

A reminder to please place garbage and recycling receptacles off the street and behind the curbline on your own property. This helps with snow plowing and avoiding hitting the receptacles. **Questions?** Contact the Orono Police Department at 952-249-4700.

## Safety Tips: Smoke Alarms & Carbon Monoxide Alarms

### Smoke Alarms Do Save Lives!

- Smoke alarms are critical for life safety as they provide an early warning in the event of a fire.
- Three of every five fire deaths were in homes with non-functional smoke alarms or no smoke alarm at all.
- Dead batteries cause 25% of smoke alarm failures.
- Fire codes require homes to have smoke alarms in every bedroom, or directly outside each sleeping area, and on each level of the home, including the basement.
- Smoke alarms should be installed according to manufacturer instructions and high on a wall or ceiling.
- Smoke alarms should be tested monthly by pushing the test button and be sure to replace the batteries at least once per year.
- Smoke alarms and carbon monoxide alarms should be replaced every 10 years.



### Carbon Monoxide is the "Invisible Killer", as it is an odorless and colorless gas that is deadly!

- Carbon Monoxide (CO) kills an estimated 400 Americans each year.
- CO Alarms should be installed close to sleeping areas and on every level of the home.
- CO Alarms should be checked monthly and replaced every 8-10 years.
- If your CO Alarm is sounding, evacuate the house and call 9-1-1.
- Make sure vents for clothes dryers, furnaces, stoves and fireplaces are clear of snow build-up.
- Gas and charcoal grills can produce CO, so only use them outside.
- A vehicle running inside a garage produces major CO, and is very dangerous.
- Generators should only be used outside away from windows, doors and vent openings.
- Common CO Sources in the home: Clothes dryer, water heater, furnace or boiler, gas and wood burning fireplaces, wood stoves, grills, generators and motor vehicles in the garage.

## Mound Firefighters Working Hard to Protect & Serve

In 2024, the dedicated Mound firefighters worked hard to support the four communities they protect and serve. Our Fire Department and firefighters are very active within and around the community by helping and serving others. In 2024, our firefighters successfully accomplished big things!

- Firefighters responded to 725 emergency calls, logging a total of 9,364 hours.
- 281 calls were fire related, and 444 were medical related.
- On weekends, firefighters performed detailed truck checks, maintenance on equipment and on the fire station. A total of 1,002 hours were put into Saturday morning maintenance.
- Firefighters attended training every Monday evening for a total of 2,000 hours.
- The Department was involved in around 60 public relations events, with numerous hours donated to various organizations and activities.
- The Department hosted its annual Fish Fry and Dance on the first Saturday in June.

Our staff is proud of what they do to protect and serve, 24 hours a day 365 days per year.



### **Hennepin County Projects – Mill and Overlays and Trail Crossing**

This year, the county is preparing plans to mill and overlay CSAH (County State Aid Highway) 15 throughout the City of Mound and into Spring Park, and CSAH 110, from Our Lady of the Lake Church and School on the south end, north to Sunnybrook Circle in Minnetrista. Mill and overlay projects consist of removing several inches of the existing pavement followed by the placement of new asphalt. This restores a smooth ride and adds life to the roadway section so complete road reconstruction is less frequent. There will be some lane configuration changes to the CSAH 110/15 intersection with the project, where 110 will be reduced to one lane in each direction with dedicated left turn lanes, instead of the dual lanes that exist today. Additionally, the Dakota Trail Crossing at CSAH 110 will be modified to include a median island and additional safety control to enhance the crossing for trail users.



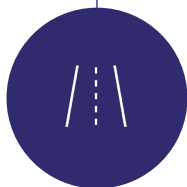
### **Lost Lake Commons Park (Three Phases)**

The first phase of the Lost Lake Commons park project is substantially complete. Grass seed was placed over the winter and should germinate in the spring. Please stay off of the grass until it is thick and growing well. The second phase of the project is scheduled to be designed and bid this spring for late summer construction. This portion will include some more landscaping around the perimeter and the addition of concrete to the plaza spaces. The third phase will include the installation of a shelter and additional improvements to the lake area. Phase three is expected to occur in a few years.



### **Lift Stations - Highlights**

Work is continuing on the replacement of the lift station at Sunset Road. Final equipment parts will arrive soon and be installed so that the new station can soon be operational. The existing station will be decommissioned and removed in the spring. Design is underway for the replacement of the lift station on Dove Lane and Woodland Road. The new station will be placed to the south on Dove Lane. Expect construction to occur later this summer.



### **Street Projects**

Feasibility studies are underway to assess the needs and costs of planned street improvement projects. The 2025 street reconstruction area consists of the neighborhood on the east side of the Three Points peninsula. A mill and overlay project is slated for the Sugar Mill neighborhood. Both projects are anticipated to occur in late-summer/fall.



### **Sidewalk Project**

Final plans are underway to replace cracked, broken and settled sidewalk along CSAH 15 between Belmont Lane and Seton Channel early this summer. The project will also upgrade the remaining pedestrian crossings to meet today's standards. This is a joint project between the City of Mound and Hennepin County and is the last of the many projects that have helped upgrade this corridor before the mill and overlay project that will occur later this year.

### Rain Barrel Program

Again in 2025, the City of Mound is teaming up with the Harrisons Bay Association and Recycling Association of Minnesota to offer rain barrels for sale! These barrels, 45-gallon barrels made from recycled plastic milk jugs, retail for \$120, but will be made available through the Recycling Association of Minnesota for \$100! Mound residents will receive a \$30 credit thanks to the City of Mound (\$20/barrel) and the City Engineering Firm, Bolton & Menk (\$10/barrel).

#### Rain Barrel benefits:

- Rain Barrels reduce the amount of stormwater run-off that enters the lakes  
Note: Stormwater often captures and carries pollutants like road salt and fertilizers as it travels.
- Barrels provide an estimated 1,400 gallons of rainwater per season! Often, people use this fresh water source for things like gardening and other outside activities. This rainwater can help reduce your water usage and save our precious water resources!



The sale opens on March 1st. **Rain barrel supplies are limited.** Visit [harrisonbay.org](http://harrisonbay.org) to get your name on a list and to receive an email when the sale goes live.

The Harrisons Bay Association will coordinate orders and hold a pick-up event on May 3rd at the Mound Public Parking Ramp. Homeowners will receive information about how to install and maintain the rain barrels as well as other landscaping techniques that can help keep polluted run-off out of creeks and lakes.

### Parks with Wide Open Spaces: Spotlight on Philbrook Park

Philbrook Park is located between Dutch Lake and Lynwood Boulevard with the easiest access being to turn north on Southview Lane from Lynwood Boulevard. Parking is available along Clover Circle, which surrounds the entire park.

Philbrook Park is generously sized and has multiple amenities including a full basketball court, a baseball diamond, and a playground with options for both older kids and toddlers. There are also multiple picnic tables, as well as a quaint shaded wooden table. A real gem to this park however is that the green space takes up a large amount of space making it perfect for passing a Frisbee, tossing a football, and/or letting the kids run and get some energy out. There are sunny spots to catch some sunrays and shade trees to keep cool. This park is a good year-round option.

Dogs are welcome at this park, but a reminder that City policy requires that dogs be leashed while visiting City parks.

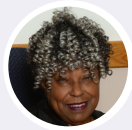
