As part of the approved plans for Phase 2 of Lost Lake Commons, updates to the current wayfinding signage and the addition of four interpretive signs throughout the park are scheduled. Attached are the revised wayfinding and interpretive sign designs intended for installation. Feedback is requested prior to final printing and placement.

The objective of the wayfinding signs is to direct visitors to notable areas within the City. The proposed designs update the signage introduced in 2008, with several enhancements:

- Greater emphasis on parks and open spaces within the mapped area.
- Public spaces and recreational activities are clearly indicated.
- Private businesses such as restaurants and gas stations have been removed from the map; instead, a QR code has been incorporated to link users to a city website that can be updated as businesses change.

Three new interpretive signs will present information on the history of Mound, created in partnership with the Lake Minnetonka Historical Society and the City, along with one sign addressing stormwater treatment.

Each interpretive sign design underwent thorough review to ensure compliance with American Disabilities Act (ADA) standards regarding both visual and reading accessibility. For optimal readability, a minimum contrast ratio of 3:1 was maintained to accommodate individuals with low vision, color blindness, and varying light conditions.

Additionally, the signs were crafted to meet public reading level requirements. The interpretive signage was developed at a sixth-grade reading level, featuring concise sentences and commonly used vocabulary to ensure clarity and accessibility for a wider audience.

The four wayfinding signs will replace existing panels around the Lost Lake Commons area and the four interpretive signs will be placed around the Lost Lake Commons park area. Signs are scheduled to be installed in the spring.

Please provide any feedback on the proposed designs that can then be included with recommendation for final approval with the City Council.

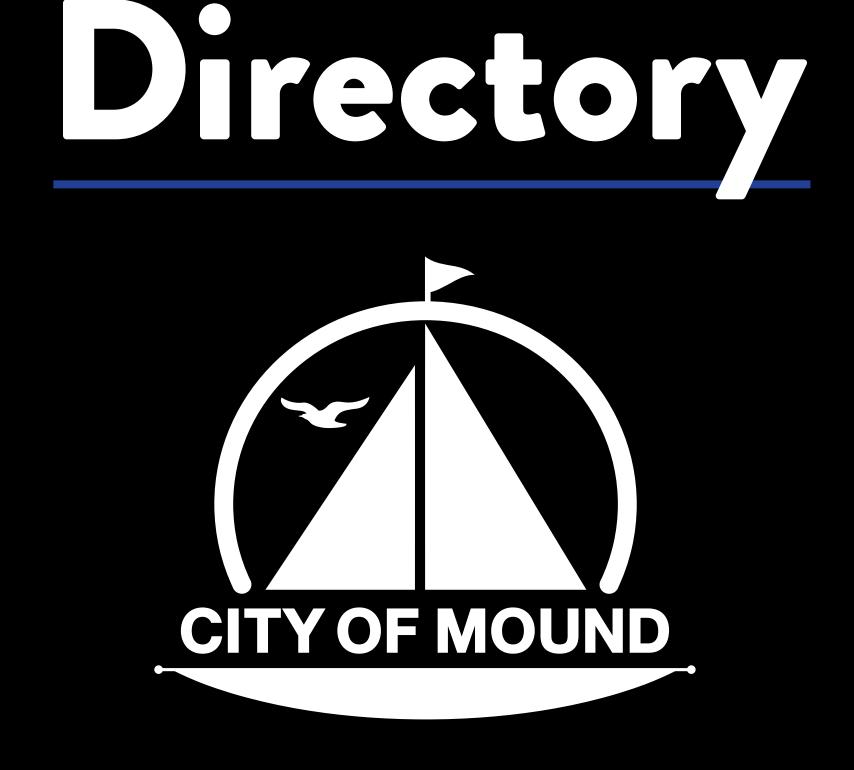

HISTORY OF MOUND



PIONEERS

Civil War veteran Major Anton Koehler moved to Mound in 1880 with his wife, Sophia, and their four children. That same year, he gave land to start Mound Union Cemetery. His sons, Edward and William, helped build Mound's businesses, schools, and community.

Levi and Christine Bowers came to Mound in 1867. Their son Elijah was the town blacksmith and was called Mound's oldest businessman by the 1950s. Their daughters, Hortense and Ellen, married the Koehler brothers—William and Edward.

Westonka Bays & Their Pioneer Namesakes

COOKS BAY is named after Mathias and Anna Carman

Cook. They built a cabin and hotel there in 1854. In 1867, they

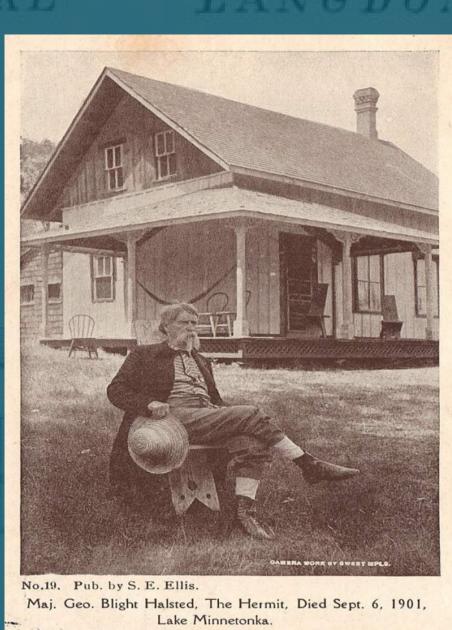
built the large Lake View House. Mathias helped start local government in 1859 and served as Justice of the Peace.

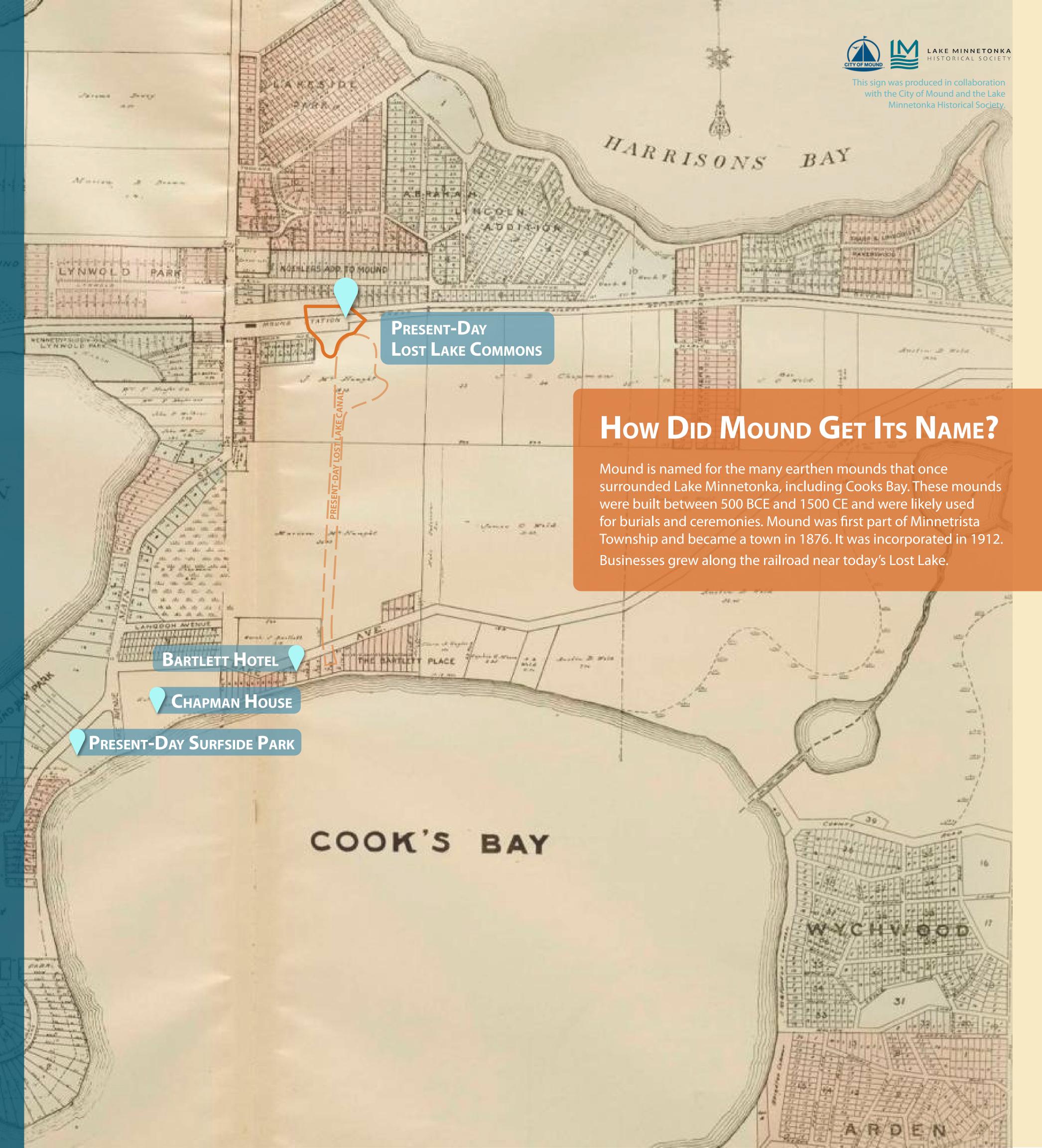
CARMANS BAY is named after John Carman, Mathias Cook's father-in-law. John worked as a surveyor and claimed land in 1853. He helped Mathias get land at Cooks Bay. John was elected head of the township board and later became the area's second school leader. His sons, Frank and Benton, started the first boat freight business between Mound and Wayzata in 1869.

HALSTED BAY is named for Frank Halsted, who settled there in 1855. He was the first Justice of the Peace in Minnetrista Township and led its first marriage ceremony.

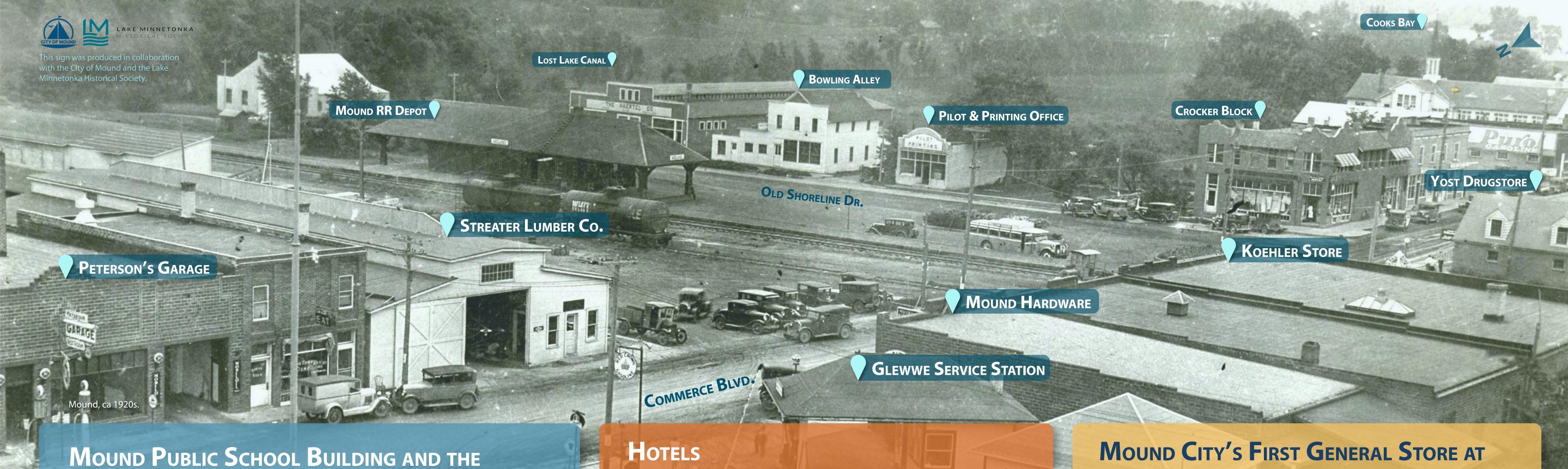
JENNINGS, HARRISON AND PRIEST BAYS are named after early settlers: Frederick Jennings (1855), shipbuilder Nathaniel Harrison (1856), and Darwin Priest (1878). Priest bought 300 acres near Cooks Bay in 1878.

LAKE LANGDON, on Mound's west side, is named after Robert and Harriet Langdon, who came from England in 1857. Robert was a Civil War veteran, and they farmed in Minnetrista.





Mound Businesses in History



BEGINNING OF TONKA TOYS

The Mound Public School was built in 1908 at Shoreline Drive and Commerce Boulevard. In 1917, a new high school opened across Commerce Boulevard. It was expanded in 1938.

In 1946, Lynn Baker, Avery Crounse, and Alvin Tesch started Mound Metalcraft in the old school building. The company made stamped metal parts. Its first product was a metal tie rack. In 1947, they began making metal toys using designs from Streater Industries. They improved the designs and showed the toys at the New York Toy Fair. The toys became very popular. In 1955, the company moved to a new building and changed its name to Tonka Toys, Inc. The factory grew for many years but closed in 1983.



By the early 1900s, many hotels were built around Cooks Bay. Popular ones were Chapman House (1875), Bartlett Hotel (1883), Buena Vista (1902), and Lake View House (1867). Sunset View Hotel (1912), overlooking Lake Langdon and Cooks Bay, is the last hotel left. It is now a private home.

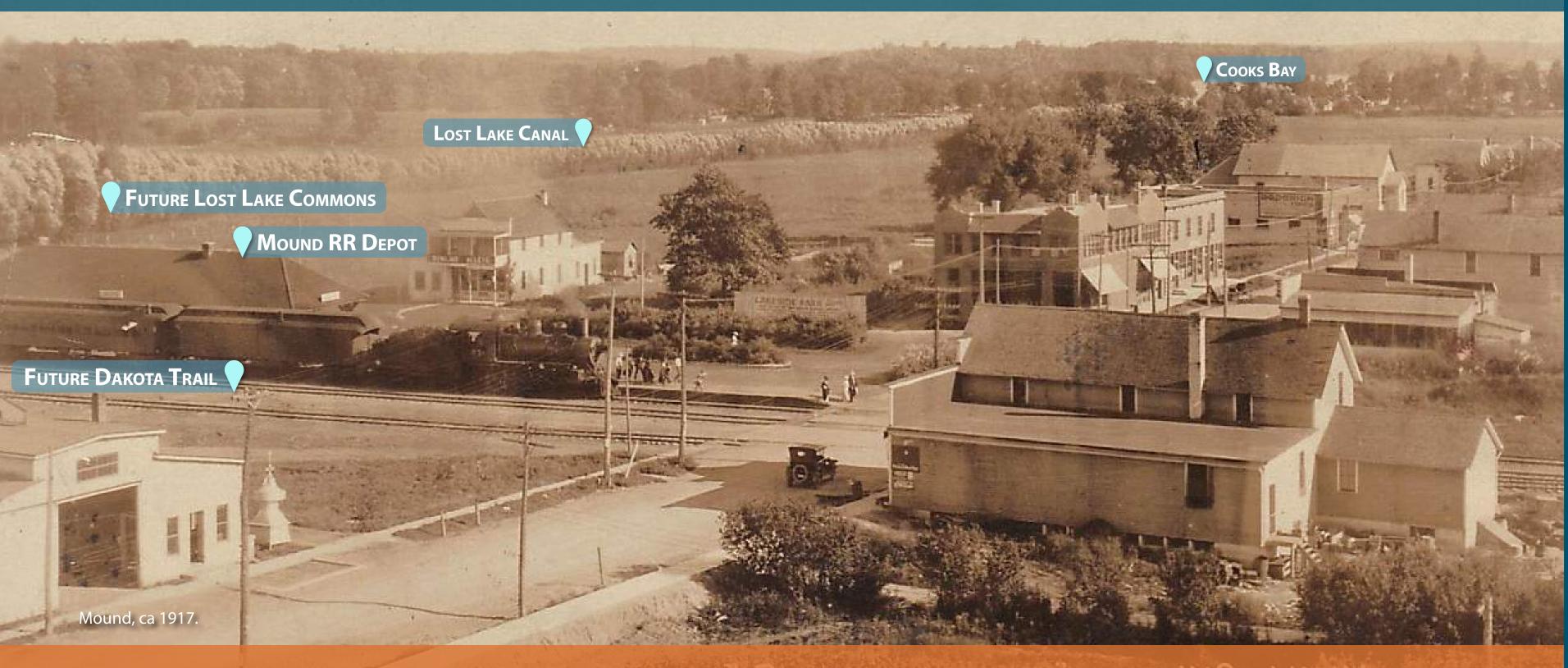


Busy Corners, 1875

In 1875, Hill, Griggs & Company of St. Paul opened the first general store in Mound. It served the firewood business at Lake Minnetonka. Henry C. Carlisle managed the store, which supplied goods to workers at Northwestern Fuel & Lumber Company. Two more general stores opened in 1876 and 1880.



HISTORY OF LOST LAKE



THE PASSENGER TRAIN

The Great Northern Railway started train service to Mound in 1900. In the summer of 1922, eight passenger trains ran each day from Minneapolis. A ticket cost 80 cents. As cars became common, train travel dropped. The last passenger train came through Mound in 1961.

How did the Dakota Regional Trail Get its Name?

Freight trains kept running after passenger service ended. They carried goods, including Tonka Toys. The rail line changed owners several times and closed in 2001. Hennepin County Railroad Authority bought the land and leased it to Three Rivers Park District. It became the Dakota Regional Trail in 2009.

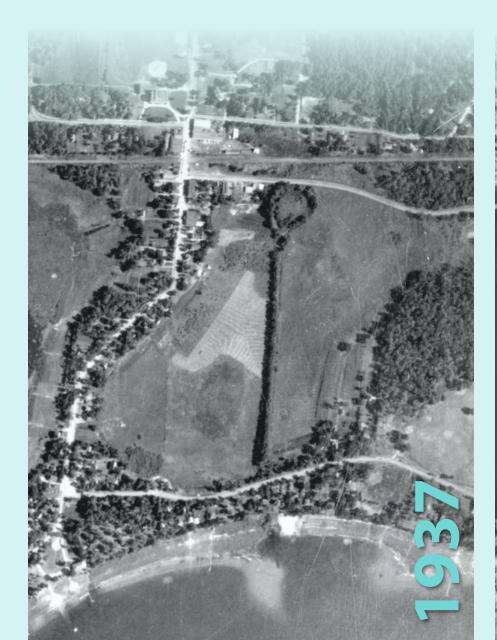
THE MOUND DEPOT

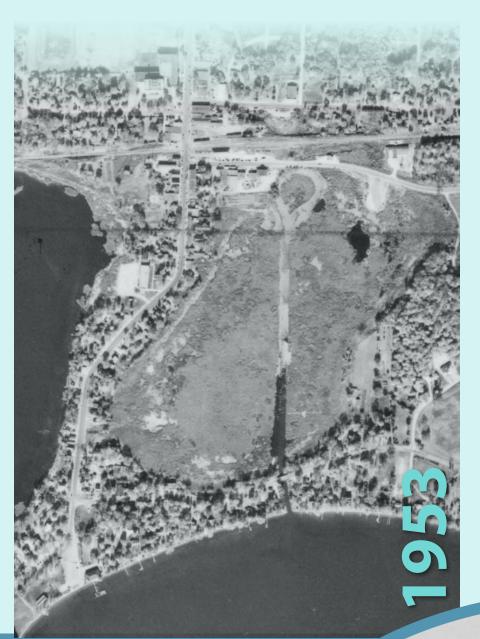
In 1902, the Great Northern Railway built a small depot east of Commerce Boulevard. A 54-foot hand-operated turntable was added in 1903. A fire destroyed the depot in 1914, and a new one was built in 1915 for \$3,398. In 1967, the depot was moved to Surfside Park on Cooks Bay. It is now used for community events.



How Was the Lost Lake Canal Created?

Lost Lake Canal opened in 1906 so steamboats could reach the railway station. The first trip through the 30-foot-wide canal was by Fred Bartlett in his steamboat named Mound. The canal soon filled with soil, even after workers planted willow trees along its banks in 1909. It was abandoned a few years later. The canal was restored in 1999 as part of the Mound Harbor District.

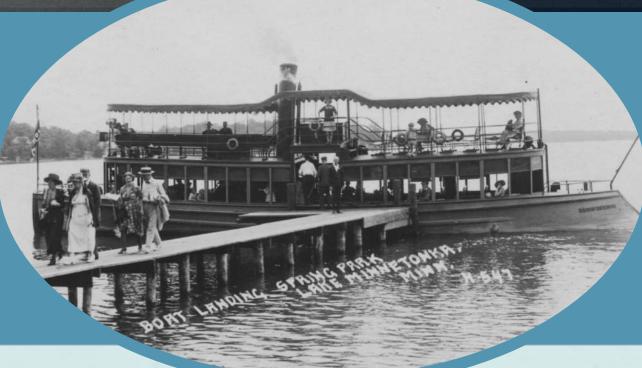


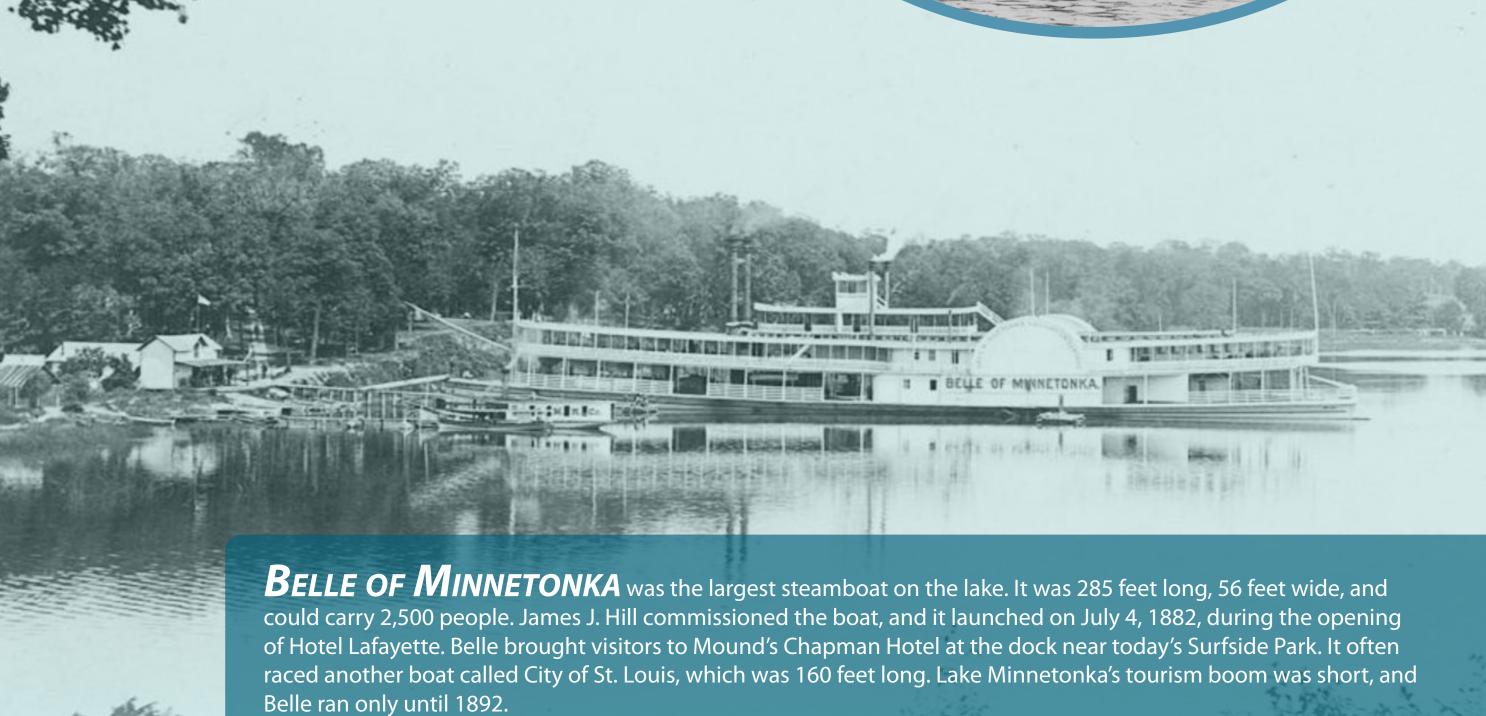




TRAVEL BY STREETCAR BOATS

In 1906, the Twin City Rapid Transit Company launched six Express Boats to connect parts of Lake Minnetonka. By 1908, boats ran every two hours from Cooks Bay to Tonka Bay. As cars became common, fewer people used the boats. Service ended in 1926.

PROTECTING THE LAKES WITH STORMWATER BASINS

Managing Stormwater Runoff

Stormwater runoff can carry pollutants into local lakes and streams if not properly managed. The City of Mound helps manage flood risk and protect freshwater by implementing various strategies to remove sediments and nutrients, including:



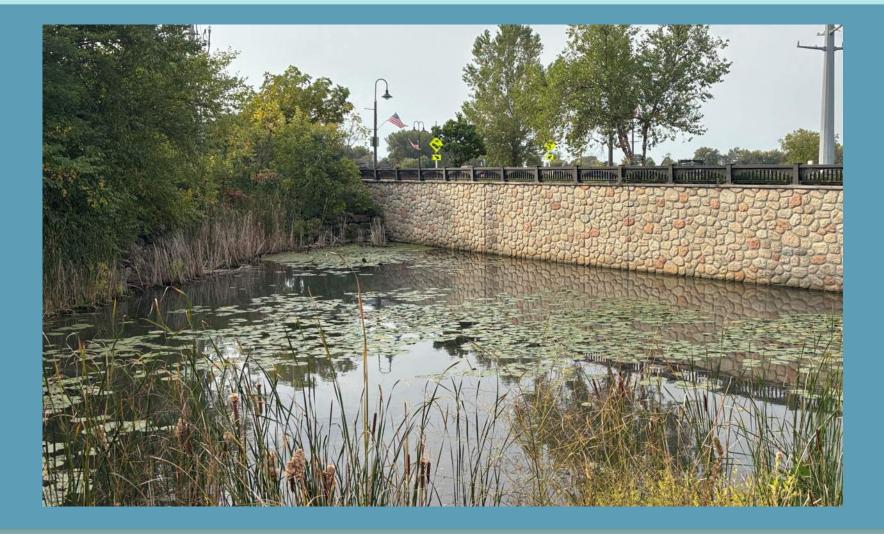
CATCH BASINS & STORM STRUCTURES

Catch basins and storm structures intake the storm water from the street or surrounding area. They are the first defense in keeping out larger pollutants, such as trash, leaves and sediments. These are maintained and cleaned by public works staff on a routine basis.



RAIN GARDENS

Rain garden is a common term used to treat stormwater and manage flood risk with the use of soils, and sometimes draintiles, to allow the basins to fill up and then slowly soak into the ground. The water and nutrients are typically used in conjunction with native moisture tolerant plants to create a "garden". They differ from wet ponds since the basin will be dry within a few days of filling up after a rain.



WET PONDS

Manage the flow of water and allow nutrients and sediments to drop out of the water prior to washing into the lakes and streams. When water enters the pond, it slows down and the ponds are built to allow them to rise and fall a few feet. This reduces the total amount and slows the speed of water as it continues downstream, reducing flood risks.
