- Rezoning to the new C-1 General Commercial District for the properties at 1632 Commerce Blvd, 5550 Three Points Blvd, 1801 Commerce Blvd, 4854 Edgewater Dr, 4400 Tuxedo Blvd, 5201 Piper Rd, and 5186 Tuxedo Blvd and for the property identified as PID No. 13-117-24-22-0265 in the Hennepin County Property Information Tax System.
- 4) Rezoning to R-1A Residential Single Family District for the properties at 3069 Brighton Boulevard and 5500 Three Points Blvd
- 5) Rezoning to R-2 Two Family Residential District for the property identified as PID No. 13-117-24-22-0022 in the Hennepin County Property Information Tax System.
