### MOUND POLICE DEPARTMENT CONSOLIDATION......Questions & Answers

### Q. Why is the City of Mound considering contracting for Police Services?

Mound's costs consistently rise, including the police costs. Everything possible is being done to minimize tax increases while maintaining the service level our residents expect. A city's police unions are subject to binding arbitration and arbitrators dictate what Mound is required to pay by law. Future costs must be controlled without losing services. Contracting for police services is a common and successful way to control costs.

# Q. Public safety is the primary 24/7 service provided by a City. How is it not the highest priority to retain our own Police Department?

The City has two choices: Fill all of the vacant sworn officer positions (3-4) and restore support staff (1), increasing costs considerably, or contract for services at a reduced cost and agree to set increases/escalators over the next 10 years, thereby reducing uncertainty. The bottom line is that we can do it more efficiently and at a lower cost with the same level of service to which we are accustomed. If we don't contract for police services, taxes will rise at an unpalatable rate.

# Q. Why were Police Services chosen to explore a contract instead of other City services?

- Contracting for police services is common among cities our size, more so than Public Works and other city functions. A larger combined Police Department allows for more scheduling flexibility, supervisory coverage, and better operational, investigative, and administrative capabilities. Achieving economies of scale requires a larger combined department than we are able to obtain on our own.
- The Mound Police Department is currently understaffed and will need to increase expenditures significantly if the department is kept in-house. The City incurs significant amounts of overtime to try to fill shifts and officer safety is a concern since often times there is only one officer on duty.

# Q. Why didn't Mound consider being the provider of Police Services to other cities instead of being the customer?

- Police Services is the largest department in the General Fund, comprising 50% of total salary and benefits and 36% of total expenditures overall.
- Salary and benefits are the most difficult expenses to manage for a city, especially in a union environment. By contracting for Police Services, the City can reduce uncertainty associated with growth in salary, benefits, workers compensation, and severance liabilities.

- The timing worked well for Mound as we are very low on officers and our Police Chief and Lieutenant positions are currently vacant. The City, at this point in time, has the flexibility to consider all of our options without having to worry about layoffs or buy-outs.
- Much time is devoted to managing and conducting wage and union negotiations on an ongoing basis. Moving to a contract for services with a neighboring city will eliminate two of the three unions and will simplify operations, allowing administration to focus on other priorities, especially redevelopment. All of the above makes the Police Department the likely candidate.

#### Q. Why has this study and ultimate decision taken so long?

- The City takes this decision very seriously. In depth study was required to come to the best possible decision and the best possible partner for us. The detailed study was necessary to ensure that the savings are substantial enough to justify giving up control of the Police Department.
- There was much to learn in this process. It took time to determine what the priorities are for the community: 1) the desire to have a police presence maintained at the Mound Public Safety Building; 2) the essential police services and programming; 3) the importance of strong leadership; and 4) the cultural elements that are needed to be preserved in order to ensure there is no drop in service levels or protection.

# Q. Are the citizens going to be allowed to vote on the decision to contract for Police Services?

- The City is very interested in the opinion of Mound residents regarding this issue, but it
  is a challenge to educate the citizens on all of the factors that need to be considered for
  them to cast an informed vote. The City is approaching this decision as a business
  decision rather than an emotional one. Everybody's first choice would be to keep the
  Police Department in-house, but the City is facing significantly higher expenditures and
  taxes if we do. The objective is for residents not to experience any difference in their
  service. If that can be attained, then the question is: How much more are you willing to
  increase your taxes to have the Police Department managed by Mound versus having
  the same services at a lower cost?
- The City will continue to look for ways to inform the public on the status of this initiative and allow for the public to provide input into this decision. It is the City's objective to control costs with minimal impact on service levels. Sometimes that means some loss of operational control and/or ownership. # Needs Volunteer Drivers

Have you heard someone say that they missed a doctor's appointment because they didn't have a way to get to the doctor's office? As you're in conversation at the coffee shop, at the Gillespie Center, at the Legion, or at church,

do you hear someone say they need to do an errand but they don't have transportation? Do you know that our community is creating a solution for transportation needs? But we need your help.

WeCAB, Westonka Community Area Bussing, has over 100 riders who have registered since the program began in October 2011. Riders register by calling WeCAN to make an appointment with our Rider Registrar for a home visit. Rider data is then entered into our dispatch software called RideScheduler.

WeCAB now has 30 volunteer drivers, barely enough to meet the rider requests. Due to the variety of personal commitments that we all have, on any given day only one-third of these drivers are available. WeCAB needs your help to consider becoming a volunteer driver.

As a WeCAB driver, you get to choose how often you drive. You get to choose your destinations, too, whether to errands around town, to the hospital in Waconia, or to appointments in our neighboring towns. You would be driving your own car, picking riders at their home, taking them to their destination, and then bringing them home again.

# No Grass Clippings or Leaves May be Blown into City Streets


The City needs to remind you that **no grass clippings or leaves are allowed to be blown onto the streets** according to City Code Section 42-4 which prohibits "Obstruction to the free flow of water in a natural waterway or a public street drain, gutter, or ditch with trash or other materials". These materials travel to our storm drains, which ultimately drain into our lakes. The leaves and clippings not only clog the storm drains, but the organic material degrades the water quality and can affect fish and other aquatic organisms' survival.

The City of Mound offers residents a location to dump leaves, weeds, garden waste, milfoil, and grass/lawn clippings free of charge at The Mulch Store. The Mulch Store is located on Highway 7, three miles west of County Road 44 at 4275 Creekview Circle in Minnetrista. Their phone number is 952-446-1056. The Mulch Store is open Monday through Friday from 9:00 a.m. to 5:00 p.m. and on Saturdays from 9:00 a.m. to 1:00 p.m. from April 1 thru November 30. Mound residents must show picture identification to use this service for free. (This location will also accept brush, limbs, logs and stumps for a fee.)

# **Voting Precinct and Polling Place Changes**

Following the 2010 census and 2012 redistricting, the City of Mound has changed voting precinct lines and polling place locations. These changes were made to even out our precinct populations, and to have polling places that meet election regulations. The following map shows the new precinct lines.



The polling places are as follows:

- Precinct 1 Mt. Olive Lutheran Church, 5218 Bartlett Boulevard
- Precinct 2 Bethel United Methodist Church, 2116 Commerce Boulevard
- Precinct 3 St. John's Lutheran Church, 2451 Fairview Lane
- Precinct 4 The Gillespie Center, 2590 Commerce Boulevard

### 2012 Elections



The Primary Election is August 14, 2012. The General Election is November 6, 2012. Polls are open from 7:00 a.m. to 8:00 p.m.

**Are you registered to vote?** If you are a new Mound resident, or have not voted in the last four years, you can pre-register to vote until July 24 for the Primary Election and until October 16 for the General Election. You can pick up registration applications at City Hall, or online at our city website: <u>www.cityofmound.com</u>. Also visit the website for other information and election forms.

**Absentee voting:** Absentee voting for the Primary is from June 29 through August 13. Absentee voting for the General is from September 21 through November 5. A voter may cast an absentee ballot in person at City Hall during regular business hours, or have an application and ballot sent by mail. Absentee ballot applications are also found on the City's website. Voters may vote by absentee ballot if they are unable to vote in person on election day for the following reasons: absence from the precinct, illness or disability, religious discipline or observance of religious holiday, service as election judge in another precinct, or eligible emergency declared by the governor or quarantine declared by federal or state government. In-person absentee voting can also be done at City Hall on the Saturday preceding the elections (August 11 and November 3) from 10:00 a.m. to 3:00 p.m.

**2012 Municipal Election:** City offices that will appear on the November 6<sup>th</sup> ballot are Mayor (2-year term) and two City Council Members (4-year terms). Filing for these city offices takes place at City Hall during regular business hours from July 31 through August 14. The fee to file for office is \$2.



#### New Name—Same Great Park

# **Internet Predators Victimize Mound Girl**

In November 2011, the Mound Police Department received a report from a mother regarding her minor daughter having contact with unknown males on the popular social media site, Facebook.

In October of 2011, the victim reported getting a friend request from an unknown male who appeared on Facebook as a legitimate 20 year old male from San Diego, California.

This guy worked the victim for only about 2 weeks and gradually won her trust. He knew all about the victim because of what she had posted on Facebook. This guy wanted to make her a model and said he was a photographer. This predator was going to pay the victim cash if she'd send him pictures of herself.

Over the course of a few days, he talked the victim into "skyping" with him, only his webcam didn't work so it was only one sided. She took off her clothes for him with the promise that money would be sent her way and she'd start her modeling career.

The very next day after skyping with the first male from San Diego, a second unknown male, posing as a 20 year old, sent the victim a message on Facebook, only this guy was from Detroit, Michigan, according to his Facebook profile.

This second male from Detroit wanted to save the victim from being exploited on the internet. The second male told the victim he saw a nude video of her on the net and could take it off if she'd contact him. He told the victim the same male from San Diego exploited his ex-girlfriend.

The victim then gave her phone number to the male from Detroit and he called her. The victim reported this second male started threatening her, telling her the nude video of her would be shown to her parents if she did not comply with him. This second male told the victim she needed to do with him what she did with the first male from San Diego in order for her video to disappear from the internet. She did.

In the course of the investigation, several search warrants were completed on email addresses, phone subscriber information, and Facebook accounts. Through information obtained from the search warrants, we identified the suspect who listed himself as living in San Diego was actually in Arcadia, California and the second one who listed himself as living in Detroit was actually in Michigan City, Indiana.

The police in Arcadia, California and Michigan City, Indiana were contacted and advised of what we had here in Mound. Both agencies ran full force with the investigation and while doing so, they were being contacted by other states' police agencies involving the same two suspects doing the same thing to other young females in their states. It was determined there could be numerous minor victims in several states. As the investigators uncovered the real identity of the suspects, we learned the suspects were not who they said they were. The suspect from Arcadia (San Diego) was not 20 years old, he was 24. He was posting pictures of himself on Facebook as a white male but he is black. The suspect from Michigan City (Detroit) was not 20 years old; he was 45 and had been doing this type of thing since 1996. He had posed himself on Facebook as a black male but is white. These two suspects were working very hard together to find young girls to chat with and ultimately exploit.

Recently search warrants were executed at both residences and arrests were made on both suspects. Computers are being examined for forensic evidence as detectives try to identify as many young females as they can. Right now there are dozens of unknown minor victims. Both parties arrested are facing several counts of Manufacturing Child Pornography, Distributing and Possessing Child Pornography. Their names have not yet been released to the public since the investigation is ongoing.

It is very important for parents to know what their children are doing on Facebook or any other social media site. It is amazing the information people put out there for the public and sexual predators know this. They work really hard when trying to find someone new they can victimize.
