Message from the Mayor

Dear Fellow Citizens of Mound,

As we begin a new year we are once again ready to face both new and lingering challenges. One of the primary challenges is maintaining services people expect and pay for, while constantly reducing the costs. The city is always trying to reinvent itself in order to gain efficiencies and reduce costs. Changes are made when new savings have been identified or it can be a result of the city making changes to meet the shifting demands over time. Revenue increases are always being examined such as expanding the tax base through growth, but cost reductions produce a more immediate return.

As you have probably heard, in December the city reorganized a couple departments. Management for both the City Clerk and Public Works Departments were reorganized. These duties will continue to be performed, but within a framework that is designed to better meet current demands.

In addition, police services are now being contracted from Orono. This creates more savings due to efficiencies that we couldn't achieve by keeping the department we had. Actually, shifting to the Orono service system was performed in stages including tests and trials that actually began the first of December followed by others throughout December. But the official and total change occurred on the first of the year.

Vacating the main floor of the police side of the Public Safety building creates an opportunity to move city hall in that existing space. Bonding restrictions limit any use of that building to governmental agencies only. There is another potential cost savings tied to this move that has not been discussed very much but has been in the back of my mind throughout this process. The council has been hearing of the need to replace the current city hall for close to 15 years. There are conceptual drawings for this in city hall from several years ago. This move puts that multimillion dollar discussion of building a new city hall to bed.

With this move, we can get new lease revenues on the old building which further helps the city finances and helps to deliver services to the public. This all boils down to lower revenues required from taxpayers. This has been, and continues to be a paramount issue for the city council.

Recent claims that the city is competing to lease space with the private sector is not entirely accurate. At the time this is being written, I am aware of only 2 potential renters of space in the current city hall. Both are pseudo-public ventures that are not able to rent on the open market long term. They tend to move around from location to location without a permanent home and sometimes have to close down for a while. The city has offered space to these quasi-public services that serve a public purpose. Offering space at rates lower than the market is the only long term solution for these services to continue. And ANY lease revenues collected are above the base line from prior years. So it is a win-win for both sides.

WeCab needs a single office to operate from, and the Westonka Historical Society has been a source of, and protector of our local history. In addition, they will now become a resource for Tonka Toy collectors world wide and will play a role in reconnecting Mound once more on a world wide stage to the Tonka Toy trademark.

Message from the City Manager ... A "Mound Magic" Update

On two separate evenings, one in October and one in November, Community Development Director Sarah Smith and I filled the house at Al & Alma's Supper Club. Dubbed 'Mound Magic," these events that included a cash bar and other refreshments, brought people up to date on what is happening in Mound. completed. What followed was an optimistic list of what is in the cue for Mound and what may develop with more time. Those included restaurant, housing, retail and hotel possibilities. More recently the Mound City Council took action commissioning an independent Market Study by a professional firm specializing in analyzing cities. Maxwell Group will take the winter months to study our community and determine the needs and what Mound can support with its population and that of our nearest neighbors. This Market Study will take the lake into special consideration and not view it as a void in the population. As those of us who live here know, the lake is not an impediment to business. A good restaurant, for instance, is a destination and we will boat or drive there. This special consideration will make up a part of the report which should positively influenced developers and business operators considering Mound as a location.

Additionally, in coming months I will be asking the City Council for approval of a professional Community Survey. In the past, Mound has used Decision Resources to systematically inquire with the public by phone as to their desires and what individuals would support. Survey results would then be prioritized and this would act as a work plan for getting things done.

Each of these tools is an essential component to continuing Mound redevelopment and community development. Public input through both formal and informal means will give City of Mound staff the direction they need in the pursuit of businesses and amenities meant to serve its residents and, ultimately, be a draw as Mound becomes a destination for visitors to share in the richness of our community. All of this will help build Mound's economic vitality, which is good for all involved!



A Low-Salt Diet for Our Lakes and Streams

A little salt goes a long way for managing snow and ice. But too much salt – which may be less than you think – can cause irreversible damage to nearby lakes and streams.

Currently, salt use is not regulated, but it poses a real threat to clean water. The chloride contained in one teaspoon of road salt can permanently pollute five gallons of water. Chloride upsets aquatic environments and can kill birds and some plants.

Many people use more salt than they need. But using more salt does not melt more ice, or melt it faster. In reality, salt only works when there is enough snow or ice for it to react with and excess crystals will eventually become a pollutant. It's best to use less than four pounds of salt per 1,000 square feet. One pound of salt fills up a 12-ounce coffee mug.

Want to protect your local lake or stream from chloride pollution? Here are some easy ways you can help:

- Apply salt or other de-icers before snow storms, so you will need less later.
- Shovel regularly to minimize ice buildup.
- Break up ice with an ice scraper before deciding if sand or a de-icer is necessary for traction. You may find that it's not.
- Use sand instead of salt when temps are -15 degrees or below.
- Sweep up any salt that's visible on dry pavement and use it elsewhere or throw it away.

ONLY YOU CAN PREVENT SEWER BACKUPS!!

Occasionally a blockage in a sewer line will result in a backup of sanitary sewage into a private home. If you experience a backup, immediately contact Public Works during business hours at 952-472-0603, or after hours call 952-472-0614.

As a resident, you play a key role in preventing sanitary sewer backups. To prevent backups, please dispose of the following items properly, not by dumping in a drain or flushing down the toilet:

- Diapers
- Sanitary napkins, rags, shop towels
- Garbage waste products such as oil, grease, gasoline, antifreeze
- Household waste such as ashes, grease, corrosives, glass, metals, paint, poisons, or solvents
- Yard waste such as sand, soil or mud

The City is not automatically responsible when a sewer backup occurs. Generally the City is responsible only if it was negligent in maintaining the main sewer lines. The sewer line from your home, business or other property to the City sewer main is your responsibility. That means that you as the property owner must schedule service and pay the cost of clearing any blockage located in the individual sewer line on your property. Gillespie Center Hosts 2nd Community Drug Forum February 21 'Chemical Use: Awareness, Prevention, Resources & Support'

An educational community forum held in Mound last November brought together drug experts and community leaders in an effort to increase awareness about drug abuse and prevention. To further expand on these topics, a second community forum titled "Chemical Use: Awareness, Prevention, Resources & Support" will be held **February 21 from 6:30-8:00 p.m.** at The Gillespie Center in Mound.

Parents, students and community members are invited to attend this free presentation to learn more about drugs and drug prevention resources in the community. Following a short introduction, attendees will be able to attend two of three, 30-minute breakout sessions:

Breakout Session 1: School Resources

The Westonka School District will host a breakout session that will include administrators, counselors and school resource officers who will give a short introduction and answer questions on how parents and students can work with the schools on issues related to chemical use.

Breakout Session 2: Orono and Minnetrista Police with West Metro Drug Task Force

Community members will have the opportunity to pose questions to law enforcement professionals from the West Metro Drug Task Force. Task Force representatives will exhibit various illegal drugs and drug paraphernalia to help make them more identifiable in the community.

Breakout Session 3: Community Resources, Support & Treatment Options

A small panel of professionals, including family therapists and chemical health counselors, will briefly describe their areas of expertise. Collectively, they will offer helpful answers related to the question, "Where do I turn for help?" Financial costs and considerations, continuum of treatment options, case management support and family support issues will be addressed.
