# Message from the Mayor .....

Dear Fellow Citizens of Mound,

Spring is upon us and with it comes good news. No matter how good or bad world and national fiscal policies are, the economy can only be restrained for so long before it forces itself to break loose of its shackles. We are living in anything but a robust economy. But we are seeing signs that it is slowly breaking free and starting to move anyway.

How is this visible in Mound? By the time this is published the new Walgreens will be open for business. I realize that there are some of you that are less than enthusiastic about this, but

when a business in Mound grows larger and expands, I consider that good news. We expect that Dakota Junction, the small bistro between the new Walgreens and Dakota trail, will be built this spring/summer. I've seen an architect's rendering of what it will look like and it's lovely.

In addition to that, the unfinished Villa homes subdivision next to Caribou has been purchased, reconfigured, and will start building out beginning this year and finished in the next few years. We anticipate that this will help generate tax increment to help pay for the bonds that were used to clean up the old dump that was in that area.

And finally, we need to congratulate the Westonka Animal Hospital, which has moved into the formerly vacant building in Mound Marketplace. This is yet another business expansion in Mound!

We continue to plan and nurture the other projects that are intended for the Langdon district and the Harbor District. On another bright note (albeit less exciting) we are almost done rebuilding our city streets except for the MSA feeder streets. We are about half way through rebuilding our sewer lift stations; and, we are getting closer to the repairing and rebuilding of our entire underground sewer and water systems.

Typically, when property is newly developed, the developers pay for the infrastructure (roads, water, sewer) improvements. But in an older city like Mound, when those original systems are past their expected life span, they begin breaking down and repair or replacement is needed. When this occurs, the city is the one that has to do the repair/replacement. Even with these large costs, the city is maintaining its high Bond rating. Every year, the auditors state that this is due to the city's strong fiscal policies. This means we can access money for these projects at a lower interest rate.

Yes, even though the economy appears stagnant on the surface, the City of Mound is not sitting still. I look forward to another great year for Mound. I wish each of you a fun and safe summer.

# QUARTERLY UTILITY BILL TO GET NEW LOOK......

As a part of our continuous effort to provide services as cost effectively and efficiently as possible, the City of Mound has contracted with OPUS21 to perform the City's utility billing function. The new bill format and customer service will begin with the May quarterly billing cycle.

The City believes there are many benefits, including:

- The call center is open 8am 10pm Monday Friday, increasing customer service hours.
- The bill will resemble other utility bills, which will stand out better than our current post cards, provide the return envelope, and allow for better communication from the City.
- Customers can pay over the phone by providing their checking account information.
- Residents will continue to have the option to make monthly payments (in advance of the quarterly billing due date to avoid any late penalties) in order to help them better manage their personal finances.
- Future enhancements include the option to receive your bill via email, on-line account access, and, ultimately, on-line bill pay.

Customers are strongly encouraged to **sign-up for the Auto Pay Plan**, where amounts can be deducted from your checking or savings account. The Utility Billing Automatic Payment enrollment form is available on our website at <u>www.cityofmound.com</u> or by calling the new number for the City of Mound Utility Billing Customer Service at 651-255-0972, effective May 18, 2013.

A Deduct Meter Can Save You Money! The City strongly urges contractors/ homeowners to purchase an extra meter from the City of Mound which would be used for metering water used outside. The City ordinance states that "the sewer rates shall be based on the actual water used. Water used, but not placed into the sanitary sewer, may be deducted provided it is metered." Meters are available through the City (\$170.00) and customers are responsible for the cost and installation. Call 952-472-0603 for more information.

What Causes Sanitary Sewer Backups? Most sanitary sewer back-ups are caused by foreign materials being flushed into the system via toilets, laundry drains, floor drains, etc. When diapers, shop rags, paper towels, oil, grease, dirt and mud, cleaning pads and wipes (i.e., Swiffer, Pledge, Clorox pads/wipes) are flushed into the system, back-ups may occur.

The City is once again asking residents to watch what they are flushing into the sanitary sewer system, via the toilet, laundry tubs, floor drains, etc. Items like these can cause the pumps at the sanitary lift stations to clog, which can cause a sewer back-up into private properties. **Item of note**: If a sewer back-up occurs due to circumstances beyond the City's control, the homeowner is responsible for damages caused, not the city.

# **Trails All the Rage - Increased Trail Popularity Leads to Greater Safety Focus**

It's hard to imagine a peaceful ride along the Dakota Trail turning into conflict, or worse, an accident. But it can happen. That is exactly the reason Three Rivers Parks

trail managers are focusing attention on safety, intersection enforcement, and trail etiquette.

"People don't think of regional trails this way, but the truth is they're a lot like our road system in that you have a great variety of users all counting on each other for their safety," says Tom McDowell, Associate Superintendent at Three Rivers Park District. "It's really basic stuff like defensive driving for bikers and walkers being aware of others using the trail and not

walking 2 or 3 abreast. It's sharing the trail, staying to the right, being courteous, wearing a helmet and stopping at stop signs. Part of our challenge is that many trail users just want to tune out the world and relax and enjoy a walk or a ride in nature. We want people to be able to do that, just not at the expense of others safety or experience on the trail." McDowell adds that young trail riders should be given some extra room, and dogs must

> always be on a 6 foot leash and not block the trail.

According Council to Metro statistics, Three Rivers Parks had more than eight million visitors last year. Roughly a third of those park visits were on regional trails. Three **Rivers Parks manages and maintains** nearly 100 miles of regional trails across suburban Hennepin County and linking into the Minneapolis trail system. One of the most popular trails is the Dakota Rail trail which traverses Mound and

numerous other Lake Minnetonka communities.

Want to help protect clean water as you plan to beautify your yard this spring? The Minnehaha Creek Watershed District (MCWD) can help. The MCWD offers grants for projects that protect water resources in a variety of ways, regardless of whether you live near a lake or stream. The deadline for residential projects is May 31, 2013.

Polluted stormwater runoff is the biggest water quality problem we face today. In developed areas, rainwater flows off roads, parking lots and rooftops, carrying dirt, fertilizer, pesticides and other harmful material into lakes, streams and wetlands. Eroded shorelines and streambanks also contribute sediment and excess nutrients to waterways. The poor water quality that results affects recreation, fish and wildlife, and reduces property values.

The MCWD encourages using stormwater Best Management Practices (BMPs) that catch polluted stormwater before it reaches nearby water bodies. The District can help you plan what's best for you and **pay for up to half of the cost** of your project.

Projects eligible for MCWD Cost Share grant funding include:

- •Raingardens planted depressions that filter stormwater
- •Pervious pavers hard surfaces which allow water to pass through
- •Native plantings along streambanks and shorelines that prevent erosion, filter and absorb pollutants
- •Any other innovative BMP that captures and filters stormwater

Grants are available for improvements on any public and private property located within the Minnehaha Creek Watershed District, including residential homes, apartments, businesses, schools, corporations, or cities.

## **SPRING & SUMMER RESIDENT FAQs**

#### How do I Report a Nuisance Concern or Complaint?

The City of Mound has a complaint-based code enforcement policy. If you wish to report a condition you feel may be a violation of Mound's City Code, contact the Community Service Officer 952-472-0603. State statute requires such matters to be handled confidentially. While Staff does their due diligence to resolve nuisance issues in a timely manner, there are matters and/or circumstances that take some time to achieve compliance. Feel free to call for a status update.

#### Do I Need a Permit for a Banner or Temporary Sign?

In 2012, the City Council approved amendments to the sign regulations that allow temporary banners and portable signs for up to 30-days. Previously, banners were allowed up to 15 days and portable signs were allowed for 10 days. To expedite approval, portable sign placement on public property may be approved by the City Manager. A temporary sign permit is required for both banners and portable signs.

#### When is Construction Noise Allowed?

For construction activity on any residentially zoned property, no person shall engage in, permit, or allow construction activities involving the use of manual tools, movement of equipment or power equipment, including, but not limited to, any kind of electric, diesel, or gas-powered machine, at any time other than between the hours of 7:00 a.m. and 9:00 p.m. on weekdays, and 8:00 a.m. and 9:00 p.m. on public holidays, Saturdays and Sundays.

### SPRINKLER RESTRICTIONS IN EFFECT

Just a reminder that, per Mound City Code 610.50, Subd 12, sprinkling restrictions are in effect May 15 to September 1 each year. Properties with even numbered addresses may sprinkle only on days with even numbered dates. Properties with odd numbered addresses may sprinkle only on days with odd numbered dates. A one (1) month exception from the odd/even sprinkling restriction may be granted for newly planted sod, grass or landscaping upon registering for exemption and approval by the Public Works Superintendent. Other exemptions will be considered on a case-by-case basis. Questions? Call Amy at 952-472-0603.

### FREE GRASS/LEAF DUMPING

The City of Mound offers residents a location to dump leaves, weeds, garden waste, milfoil, and grass/lawn clippings free of charge at The Mulch Store. The Mulch Store is located on Highway 7, three miles west of County Road 44 at 4275 Creekview Circle in Minnetrista. Their phone number is 952-446-1056. The Mulch Store is open Monday through Friday from 9 a.m. to 5 p.m. and on Saturdays from 9 a.m. to 1 p.m. from April 1 thru November 30. Mound residents must show picture identification to use this service for free. This location will also accept brush, limbs, logs and stumps for a fee. Questions? Call Amy at 952-472-0603.

Residents in the program are reminded to comply with all requirements as listed in the Dock Ordinance Section 78 of the City Code (see website). Fines and/or potential revocation of the dock license may apply for non-compliance. The most common violations include: failure to declare watercraft, not having a valid DNR registration on file, or leaving debris on the commons or dock site.

## **Mound Fire Department Hires Six Probationary Firefighters**

There is a problematic trend across America within the volunteer fire service of fewer and fewer people volunteering for firefighting duties. There has been a decline in the number of active volunteer firefighters in the United States by approximately 130,000, from 1984 to 2010.

Over its long history, the Mound Fire Department has been very successful in maintaining a full complement of volunteer firefighters. In an effort to maintain a high quality fire and rescue staff, Mound Fire recently hired six firefighters who started on March 4, 2013 as probationary firefighters. The six new firefighters are Nick Farley, Danny Grady, Chris Heitz, Jed Kobernusz, Aaron Morrison and Dan Patterson.

The hiring was in response to retirements over the past couple of years, combined with planning for future staff retirements. Hiring firefighters now ensures a fully trained staff and excellent fire and rescue response now and in the future.


# Fire Safety Tips

#### Put a smoke alarm on every level of your home, outside each sleeping area, and in every bedroom.

- Smoke alarms can be battery-operated or electrically hardwired in your home and are available at a variety of price points.
- If you have hearing problems, use alarms with flashing strobe lights and vibration.
- Test smoke alarms every month. Replace batteries once a year, even if alarms are hardwired.
- Mount smoke alarms high on walls or ceilings since smoke rises. Ceiling-mounted alarms should be installed at least 4 inches away from the nearest wall. Wall-mounted alarms should be installed 4 to 12 inches away from the ceiling.
- Replace all smoke alarms every 10 years.
- Consider installing both ionization alarms, which are better at sensing flaming fires, and photoelectric alarms, which are better at sensing slow, smoky fires, or dual sensor alarms.

# VERTICAL CLEARANCES UNDER LAKE **BRIDGES**

There are 16 county-maintained channels on Lake Minnetonka that pass under a bridge. Basic safe boating involves an understanding of your boat height on the water, the current water level and bridge clearances prior to entering a channel.

The following list gives the vertical clearance under bridges (the lowest bridge is used if there is more than one over the channel) to the normal lake elevation 929.4 feet. Temporary cables, wires, ropes, and changes in lake elevation may reduce vertical clearance to something less than that listed. For current lake elevations please call the Minnehaha Creek Watershed District at 952-471-0590.

If your boat has clearance at Black Lake, you will also have clearance at Lost Lake and you can get to downtown Mound!

On January 1, 2013, the Orono Police Department (OPD) expanded its police service area. The Cities of Mound and Orono worked out a cooperative partnership to provide police services to the City of Mound. The Orono Police Department also provides police services to the cities of Spring Park and Minnetonka Beach.

This partnership brought 11 additional officers to OPD. Each new officer brought with them different skills and knowledge, making an even stronger organization. Great effort made everything as seamless as possible, resulting in a very positive outcome.

The current level of staffing is at 27 licensed full-time police officers, 3 part-time police officers, 3 office support personnel and a community service officer. The

most recent additions were the hiring of two part-time officers: Jason Barnes and Philip Spanjers and one administrative assistant, Heather Gehlen.

The Orono Police Department prides itself on making the communities feel safe through diligent traffic enforcement and by building strong lasting relationships with citizens and businesses. We encourage people who live, work and enjoy our communities to participate in the partnerships we are forming. ### Police Explorer Program Openings for Youth

Law Enforcement Police Exploring is a youth career program facilitated by the Learning for Life Organization and sponsored by various police agencies. The Orono Police Department has continued the Police Explorer Program established by the Mound PD in 2008. Police Exploring is open to young adults age fourteen (and past the eighth grade) to age twenty. Law Enforcement Exploring provides educational training programs for young adults on the objectives and mission of law enforcement.

The Exploring program is specifically designed to incorporate career opportunities, life skills, service learning, character education and leadership experience. Explorers are trained on various mock situations ranging from traffic stops to hostage negotiation. The Explorers also volunteer their time to assist the city with city events. The Explorers may participate in the state conference which is held in

Rochester each year. Explorers also have the opportunity to earn multiple scholarships toward college level courses.

In the past three years, our local Explorer Post has earned eight state awards, including

five first place awards at the State Conference. The awards result in scholarship money to our post that the Explorers can use towards college courses. Explorers meet weekly during the school year and have opportunity to participate in ride-alongs with Orono Police Officers.
