MESSAGE FROM THE MAYOR

Dear Neighbors,

and Dakota Trails.

As we usher in the holiday season, there are many things to be thankful for! The City of Mound has seen an uptick in development interest and many exciting projects are underway.

First, after many years of preparation and hard work, a revised approach to development in the Harbor District allowed the City to balance the need to create additional tax value with a desire to preserve community spaces in the heart of downtown. Lifestyle Communities, LLC, closed on the sale of the 2.4 acres on the west end of the downtown greenspace and will develop a 52-unit, active-adult, housing cooperative, that will be referred to as "Artessa." A pre-sales gallery in the RPG Commerce Place Shopping Center will open soon and all residents are encouraged to find out more about the advantages of the cooperative model compared to a conventional condominium. Similarly, the City Council authorized a planning study that is underway to gain public input on what improvements are desired/appropriate for the remaining 3.5 acres of land that will optimize the current amenities including the harbor, docks, Andrews Sisters'

Other new development activities include Inland Development Partners' addition of 18 attractive, market-rate, rental townhomes at the Wilshire and Tuxedo intersection -- a piece of land that has been inactive for decades.

Reinvestment is also happening at locations including Stonegate Plaza who renewed their parking lot and is completing the build-out of the new "Hibachi Daruma" restaurant. 3Soteric Life continues to partner with complementary businesses and "Adventure Loot", a new game shop, opened next door. RPG Commerce Place has been busy with renewal and will be home to the Westonka Hockey Association's off-ice training facility. That, in addition to Anytime

Fitness, should open up opportunities for complementary businesses. Domino's Pizza continues to invest in its new location with parking lot and landscape improvements and the "Arts" has made its debut on Shoreline Drive. Lastly, the owners of Twin Cities Closets bought the old Threshold/Bank building at 2339 Commerce and have already repainted it as they envision what the space will ultimately be used for.

Maintaining community pride takes all of us!

The changing of the leaves, cooler temps, and imminent arrival of snow drive instinctive behavior for not just the squirrels and geese, but in people, too! We switch summer wardrobes in our closet for warmer winter garments, blow out our irrigation, put up the lawn mower, dig out the snow shovel, clean out the garage to make room for the car, and winterize our boats and RV's.

In all these changes and movements, we have an opportunity to identify items we no longer use or enjoy, things that don't work, and stuff that has deteriorated beyond use. Consider serving as an election judge for the 2022 midterm elections! Election judges administer voting procedures to ensure a fair and accessible election for all eligible voters. The City of Mound is always looking for qualified voters to act as election judges. Requirements include: must be eligible to vote in Minnesota, must be able to read, write, and speak English, cannot be a spouse, parent, child, or sibling of any election judge serving in the same precinct, and cannot be a candidate or the spouse, parent, child, or sibling of any candidate on the ballot in that precinct.

Election judges go through a two-hour training and are compensated for their service. The City is seeking judges able to help with early voting and all judges must be able to work on the Aug. 9 primary election day and November 8 general election day — full-day shifts are from 6 am to approx. 9 pm, with 1/2 day shifts available. ICE SAFETY REMINDERS:

New ice is usually stronger than old ice. Four inches of clear, newly formed ice may support one person on foot, while a foot or more of old, partially thawed ice may not.

Ice seldom freezes uniformly. It may be a foot thick in one location and only an inch or two just a few feet away.



The insulating effect of snow slows down the freezing process. The extra weight also reduces how much weight the ice sheet can support. Also, ice near shore can be weaker than ice that is farther out.

Booming and cracking ice isn't necessarily dangerous. It only means that the ice is expanding and contracting as the temperature changes.


Schools of fish or flocks of waterfowl can also adversely affect the relative safety of ice. The movement of fish can bring warm water up from the bottom of the lake.

Emerald ash borer discovered in Mound. The Minnesota Department of Agriculture (MDA) confirmed an emerald ash borer (EAB) infestation in the City of Mound in August of 2021 at a private residence. There are several things residents should look for when checking for emerald ash borer, including: be sure you've identified an ash tree, look for woodpecker

damage, and check for bark cracks. If you feel your ash tree may be infested with EAB, contact a tree care professional, or the MDA at arrest.the.pest@state.mn.us or 888-545-6684.

The biggest risk of spreading EAB comes from people unknowingly moving firewood or other ash products harboring larvae.

Minnesota has the largest population of ash trees, so please educate yourself on the risks. For more information on emerald ash borer, go to www.mda.state.mn.us/eab or see the City's website.





On September 11, the Westonka History Museum celebrated its post-COVID re-opening with a history talk on water skiing by Tom Skramstad, an Open House at the museum, and door prizes for the first 25 visitors!!

Tom shared his research on the origin of the sport of water skiing, and the creation of the first skis. He shared fascinating details of the lives of those early skiers. Included in his talk were slides of skiers becoming performers,

building jumps in Cook's Bay in front of the Casino, and later slides of the crowds of people lining Lake Harriet to watch the skiers create pyramids and other feats of skill and daring!

DAKOTA REGIONAL TRAIL CROSSING UPDATE

At the June 8, 2021 regular Council Meeting, the City Council approved the final report of a study of Shoreline Drive pedestrian corridor improvements that primarily focused on the vicinity of Auditor's Road and Belmont Road, including the Dakota Regional Trail crossing. The Council supported the findings of the study that ranked and prioritized pedestrian safety and directed Staff to share the results with Hennepin County and Three Rivers Park District.

While multiple alternatives were analyzed, the recommendation is to retain the existing Dakota Regional Trail crossing alignment and add Rectangular Rapid Flashing Beacons (RRFB), both overhead and at the street level, at Auditor's Road to alert drivers when pedestrians/bikers are

crossing. In addition, the turn lanes in and out of Auditor's Road will be eliminated which will narrow the amount of pavement, and a larger central median for safer crossing will be added. A safer trail crossing at Commerce Blvd. is also under consideration. Hennepin County has signed on to the Shoreline/Auditor's Road recommended improvements which will be completed in conjunction with the mill and overlay scheduled for 2023.



Harbor District Park Improvements Master Plan Update



Thank you to everyone who participated in the Concept Plan survey this summer! Feedback is being analyzed and refined concepts will be presented to the Parks Commission on December 9th and the City Council after the first of the year.

The timing of improvements will be coordinated with Lifestyle Communities development of the cooperative housing development in order to ensure the most efficient mobilization and staging of construction.

Water Treatment Feasibility Study Update—The City has been focused on aligning resources for the estimated \$24M project. On October 28, the City participated in the MN Senate Capital Investment Committee's Bonding Projects site tour and will do the same with the House Capital Investment Committee on November 18. These are opportunities to provide an up-close view of our project and the unique financial challenges that a \$24-million treatment project would impose on our residents. These are first steps in a long process that begins as the Legislature comes into session after the first of the year and typically ends in the early summer when the State approves the biennial (every-two-years) budget process.



Volunteer Fire Fighters Staffing Update

Mound Fire welcomes four new firefighters that recently completed all of the required firefighter and emergency medical training to meet the department's recognized standards to become State Certified as Firefighter I, Firefighter II, Hazmat and Emergency Medical Responder (EMR).

The completion of Minnesota State Certification is a requirement of all firefighters employed by the Mound Fire Department. Congratulations to Travis Pounder, Derek Beiningen, Saul Calderon and Michael Jabs!

Mound Fire has a well trained staff of 41, ready to serve and protect our community!

Adopt a Fire Hydrant this winter!

Mound Fire Chief Greg Pederson asks that you please take time to clear fire hydrants of snow in your neighborhood. Please help keep hydrants accessible throughout the winter so we can be much more efficient and timely in the event of an emergency. If Fire Fighters have to locate and dig out hydrants, our response time is greatly hindered.



If you are unable to clear the snow from a fire hydrant in your neighborhood, please contact the Mound Fire Department administrative office at moundfire.com or 952-472-3555, and we will arrange to have staff clear the snow from the hydrant. Thank you for your assistance!

It's that time of year again! Change Your Clock, Change Your Batteries™!

When Daylight savings time ends on Sunday, November 7th, and you change your clocks back one hour, please change your batteries in all smoke and carbon monoxide detectors that do not have 10 year lithium batteries. It's also important to check the installation date of your detectors and replace any detector over 10 years old, which is considered its end of useful life. The National Fire Protection Association reports that 71% of smoke alarms which failed to operate had missing, disconnected or dead batteries so be proactive!!

The Mound Fire Department has 9-volt batteries supplied by *Energizer* available to residents for free. Stop by our offices soon as quantities are limited.

The Westonka Community and Commerce (WCC) Annual Tree Lighting event is scheduled for Saturday, November 20th. The event will blend the traditional downtown event with last year's View Santa Tour with a fire truck parade throughout the community. Santa's entourage will leave the Fire Department at 4:30, tour the neighborhoods, and culminate with the Tree Lighting at Veterans Park planned for approximately 7:15pm. Santa and Mrs. Claus will be on hand to share hot cocoa and cookies. More information on estimated times for neighborhood tours to be determined.

Police Chief's Corner

We remind you that winter parking restrictions are in effect November 15 to April 15 so there is no parking between 2:00 am -6:00 am on City streets. Please keep fire hydrants, mailboxes and house numbers free and clear of snow and debris in case of an emergency. Also, a friendly reminder to not move snow out of driveways and into the street.

The Police Department reminds you to lock your cars, garages and homes. In the past several years, criminals have learned to access your home via the garage door opener in your vehicle. Criminals are becoming more bold and we have seen a modest increase in residential occupied burglaries in which criminals access your home at night via the unlocked vehicle in the driveway. If your vehicle has a tracking capability, we also would suggest those subscriptions be used to help us get your vehicle back sooner.

Keeping the community safe and welcoming is always our top priority!

 - > Mound Multiple Slip Fee \$500 (this includes the LMCD fee and covers the increased cost of the in/out service)
 - > Regular dock sites: \$350 for first boat, \$150 for second boat (includes LMCD fee)
 - > Temporary visiting dockage permit \$150 for 10 days—limit to one per season per site

MOUND UNION CEMETERY

The City Council established a subcommittee consisting of Council Members Paula Larson and Sherrie Pugh to explore options for the next phase of cemetery improvements.

Based on the trend that the vast majority of internments since 2017 have been ash burials, the City will be exploring a combination of inground plots and a granite aboveground 'Ossuarium' similar to the one recently installed at Eden Prairie's Pleasant Hill Cemetery for the last section of the cemetery, all of which will take time to develop.

In the interim, concepts to beautify the entry will be explored.

Republic Services contract for curbside singe-sort recycling renewed

Republic Services (formerly Allied Waste) has been the City's curbside recycling vendor since moving to single sort carts in 2007. Much has changed in the recycling industry since that time, mainly the intense price pressure because the after-market demand for recycled materials has dried up, particularly from China.

The approved contract is for a 5-year flat rate with an optional 5-year extension using the existing carts and continuing to replace carts as needed due to cracks, damaged wheels, etc. Republic Services is offering residents an option to pay a \$35 one-time fee to change out a cart for cleaning and residents can contact Republic via email to customerfirst@republicservices.com or by calling (952)941-5174 for more information on the Cart Replacement Program. A credit card payment from the resident will be taken at the time of request.

Republic has been a very responsive vendor when it comes to addressing customer service concerns/missed pick-ups, as well as has a strong working knowledge of Mound streets and routes, some of which can be quite challenging. The City currently charges \$4 per month for recycling services that include the curbside single-sort service, the Mulch Store leaf drop-off service and annual spring clean-up day. The rate will increase to \$5.25 per month to cover the cost of the new contract. 
