RESOLUTION REAFFIRMING A MOTION TO AWARD BID FOR SURFSIDE PARK PLAYGROUND IMPROVEMENTS CITY PROJECT NO. PW-24-10 AND FINALIZING PLAYGROUND ORIENTATION

WHEREAS, pursuant to an advertisement for bids for the Surfside Park Playground Improvements Project, bids were received on March 5, 2024, opened and tabulated according to law, with the following bids received and complying with the advertisement:

WHEREAS, Mound City Council, at its regular meeting on March 12, 2024, voted 3-2 to award the Surfside Park Playground Improvements contract to Blackstone Contractors, LLC with the "Alt 1 (sod)" alternative; and

WHEREAS, Mound City Council discussed alternatives to the orientation of the Playground equipment at a workshop on March 12, 2024; and

WHEREAS, Mound City Council reached a consensus to approve the layout presented by Bolton and Menk, attached as Exhibit A; and

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Mound, Minnesota, that the City Council reaffirms its motion to award the Surfside Park Playground Improvements contract to Blackstone Contractors, LLC. and authorize the Mayor and City Clerk to enter into a contract with Blackstone Contractors, LLC. based on the Base Bid + Alternate 1 (sod) lowest bid amount in the name of the City of Mound.

NOW, THEREFORE BE IT FURTHER RESOLVED by the City Council of the City of Mound, Minnesota, that City staff are hereby authorized and directed to coordinate electrical modifications in the name of the City of Mound for the Surfside Park Playground Improvements.

NOW, THEREFORE BE IT FURTHER RESOLVED by the City Council of the City of Mound, Minnesota, that the orientation of the Surfside Park Playground structure conforms with Exhibit Α.
